#### Medford PD Drug Unit Gangs and Drugs in Schools

Lt. Tim Doney and Sgt. Kevin Walruff are assigned to the Medford Area Drug and Gang Enforcement (MADGE). During the course of their drug investigations they have encountered a number of situations with a connection between gangs and drugs. They will be presenting a class on this connection and some of the current emerging trends that are being seen. If time permits, a case study will be presented in which a heroin ring with gang connections was broken up.

#### Internet Crimes Against Children Online Investigations

The Oregon Internet Crimes Against Children office in Salem will be presenting a class in online investigations. They will be presenting information on what the ICAC program is about and how they can assist SRO's who are conducting investigations involving online cases.

#### Officer Kelly Van Blokland Minimal Resource Response to Active Shooter

Officer Van Blokland has been with the Portland Police Bureau since 1993. He worked in a patrol capacity, including six years with the mounted patrol. He was assigned to the SERT Team in June of 2007, and was assigned to the Inner Perimeter team. He transferred to the Training Division as a lead firearms instructor in August of 2010. He has been a firearms instructor for over 10 years and assists with patrol tactics and instruction for new hires in the active shooter response.

#### Brian Hungerford Current Law Issues

As a partner in the Hungerford Law Firm, Brian has represented school districts in areas of labor relations, federal and state court, agency hearings, arbitrations, and collective bargaining. He is co-editor of the Oregon Labor Law Today, the Oregon Labor Law Digest, and an adjunct professor at Lewis & Clark College. He will be covering search and seizure as related to SRO's, use of canines, and any updates with the Camreta vs Greene case regarding interviews with students. He will also address any specific questions that may be presented to him.
